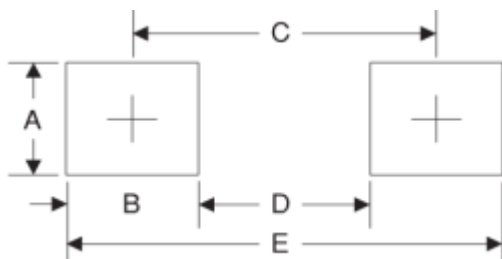

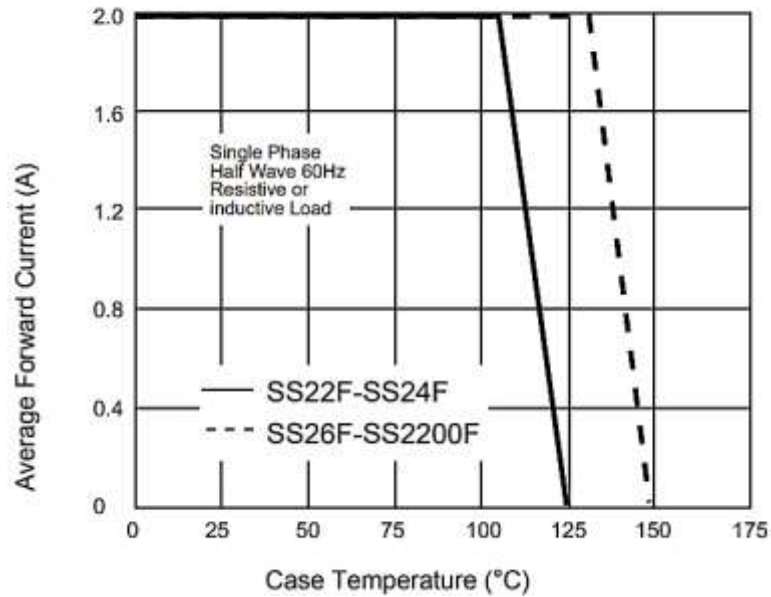

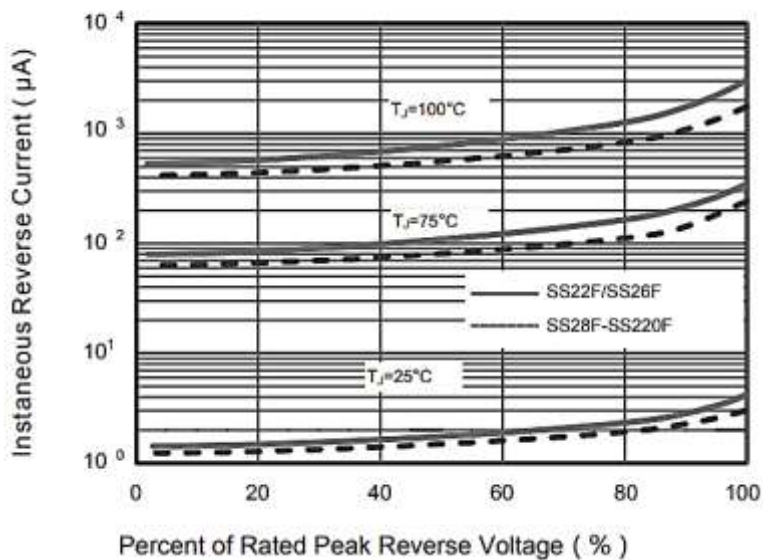

**Fig.1 Forward Current Derating Curve**

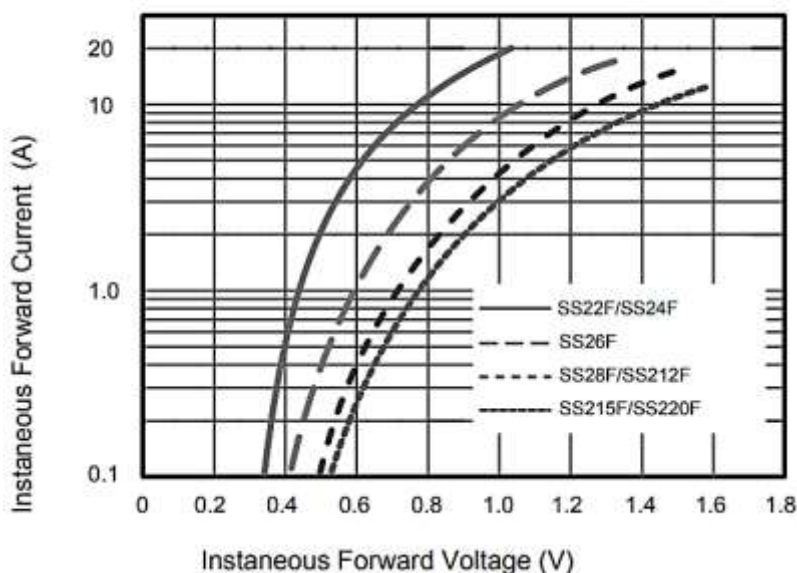


**Fig.2 Typical Reverse Characteristics**

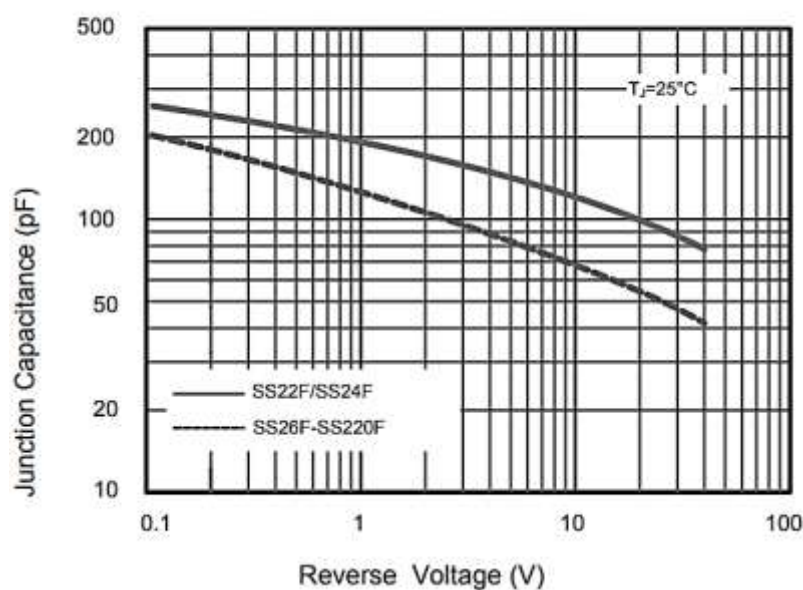

**Fig.3 Typical Forward Characteristic**



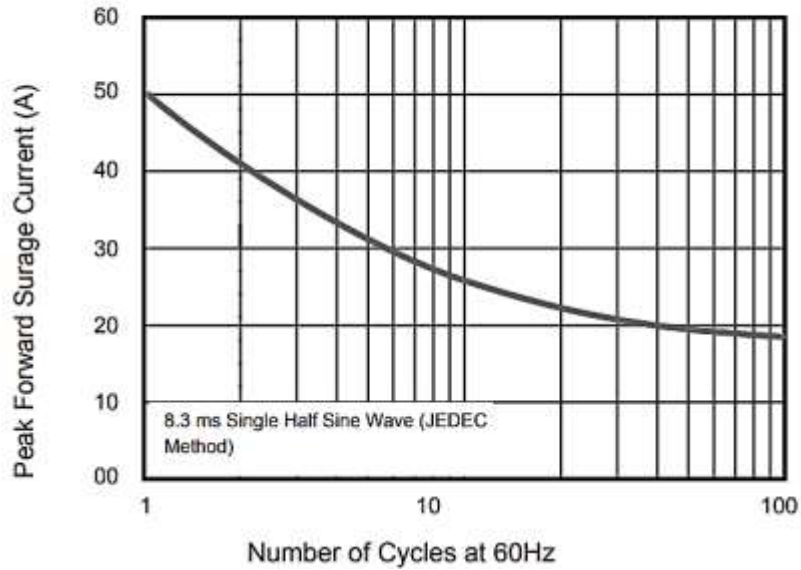
**Fig.4 Typical Junction Capacitance**



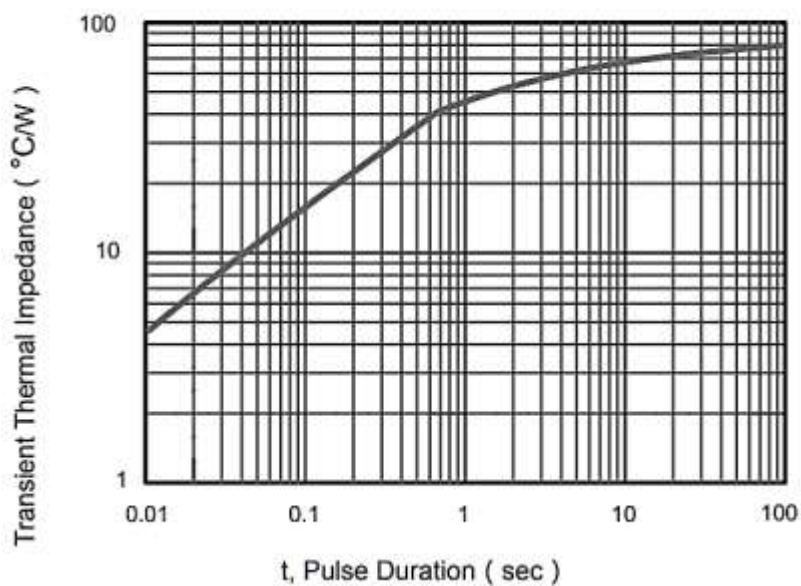


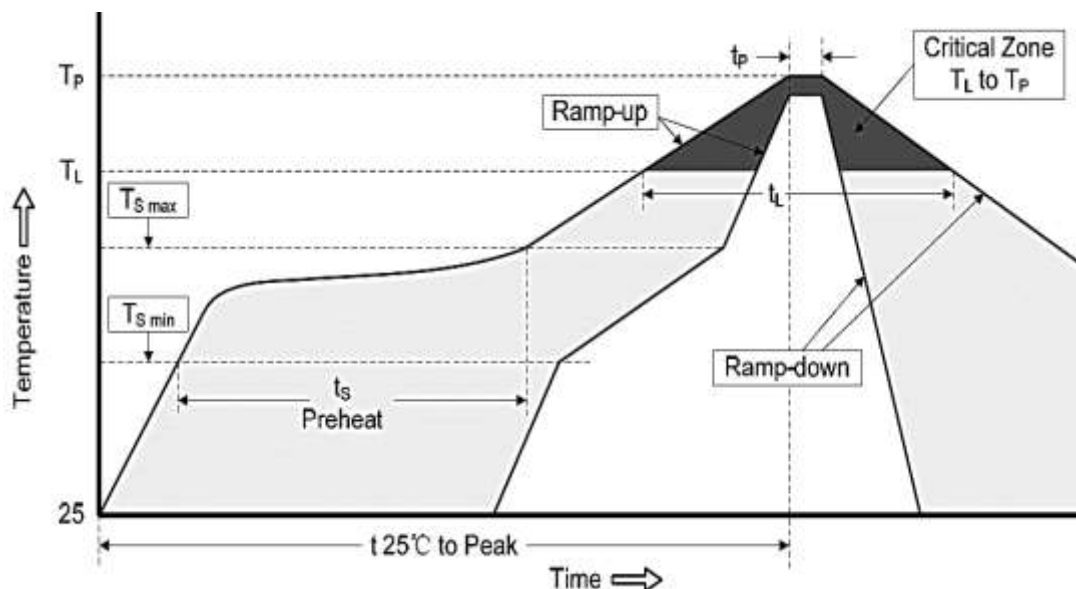

**Fig.6- Typical Transient Thermal Impedance**

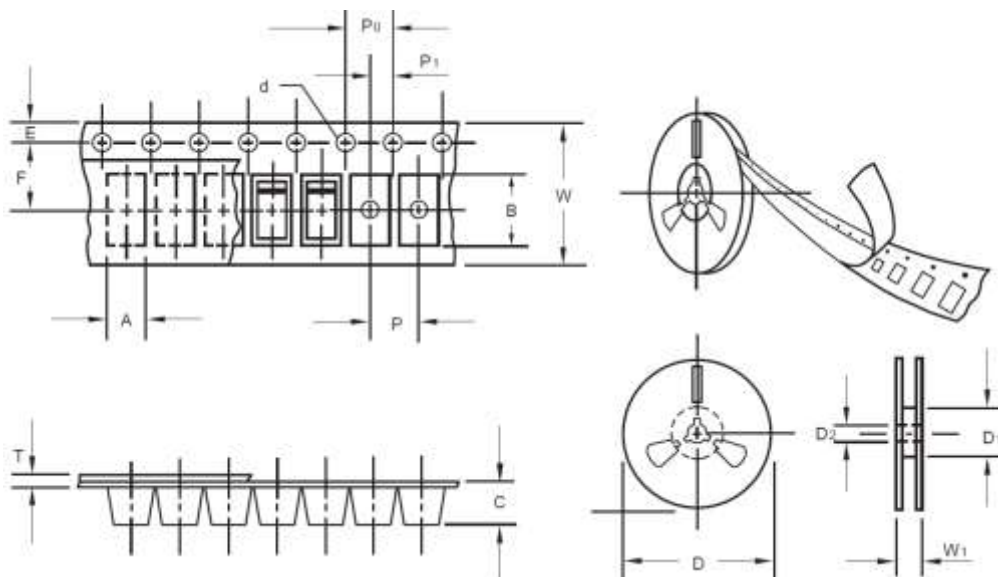
